## What Is Legal Metrology?

Legal Metrology is the part of law that deals with the regulation of measuring tools and units used in trade. It ensures that people receive the right quantity of goods when they buy products like milk, petrol, flour, or electronics.

To control unfair trade practices, the government has made it compulsory for businesses to register under legal metrology. This applies to both local manufacturers and international importers of packaged goods.

# Who Needs a Legal Metrology Certificate?

You may need a Legal Metrology Certificate if you:

## 1. Manufacture Weighing or Measuring Instruments

If you are making products like weighing machines, fuel dispensers, or any other instrument that measures quantity, you need a [Legal Metrology Manufacturer License Registration](#).

Even if you don't make or import goods, but simply sell pre-packaged items, you are required to comply with legal metrology packaging standards.

## 4. Develop New Measuring Models

If you design a new type of weighing or measuring device, you need to go through [model approval certificate registration](#) before you can sell it in the market.

# Types of Legal Metrology Registrations

Here are the main types of registrations under Legal Metrology:

## 1. Legal Metrology Online Registration

This is the general term for all online applications made under Legal Metrology. Whether you're applying for a manufacturer license or LMPC, the government portal allows you to register online. It is quicker, transparent, and avoids unnecessary paperwork.

## 2. Legal Metrology Manufacturer License Registration

This is required for manufacturers of instruments used for measurement. Without this license, manufacturers are not allowed to sell their instruments in India.

## 3. LMPC Certificate Online Registration

This certificate is necessary for importers and manufacturers of pre-packaged goods. As per Rule 27 of the Legal Metrology Packaged Commodities Rules, no one can import or sell packaged items without an LMPC certificate.

Common examples of such goods include:

- Mobile phones
- Laptops
- LED bulbs

- Kitchen appliances
- Cosmetics
- Packaged food products

## 4. Model Approval Certificate Registration

Before any measuring instrument model (like a new kind of weighing machine) is approved for use in the market, it must undergo testing. The Model Approval Certificate confirms that the model meets Indian standards.

## Step 5: Receive the Certificate

Once approved, you will get the certificate on your registered email. You can also download it from the official portal.
